“SAVE IT” Step 2: Make Your Case

Identify Your Position and Goals

Identify Your Goals for this preservation issue. These may include the following:

- Save and stabilize a site in the short term
- Protect a site long term
- Influence a planning or design decision
- Increase understanding of a preservation issue
- Raise money

Identify your best-case scenario and alternatives for negotiation.

Prepare a short (1-3 page) position statement.

Discuss alternatives with the owner/developer.

Meet in a neutral location if possible.

Distinguish people from the problem.

Establish a flexible position.

Don't fall victim to phony facts, timelines, excuses.

After discussion with the owner, distribute your position statement to make it known.

Determine Your Allies

Determine who the stakeholders are and how they are involved.

Find out if the project will be [reviewed by SHPO for use of state and/or federal funds](#).

Secure the support of other organizations or important people, including elected officials.

Determine if there is public support and what kind of support they may be willing to provide.

Plan for how you engage the public and enlist their support.

DO A REALITY CHECK: This could be a big task. Is this for you? If yes, proceed to Step 3: Advocate and Educate.
